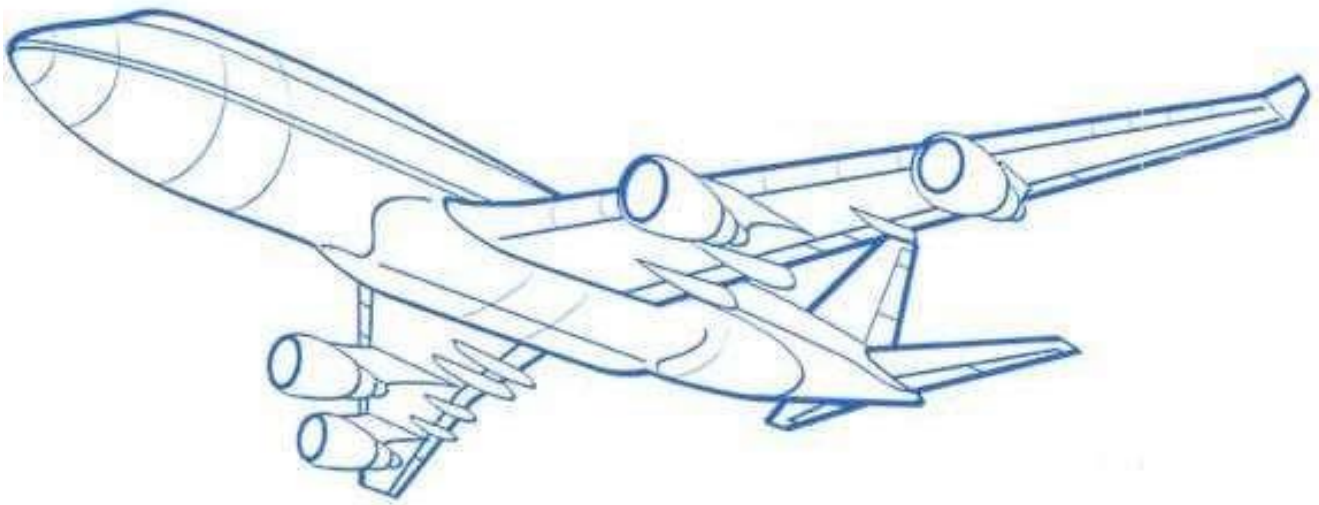

Aircraft Maintenance Engineering (AME)

An **Aircraft Maintenance Engineer (AME)**, is a licensed person who carries out and certifies aircraft maintenance. Checks condition of aircraft and engine, makes repairs, replacements and adjustments, in accordance with approved maintenance procedures. May direct the work of a number of Air Mechanics and Trades Helpers. May be required to fly with aircraft as flight engineer.

Commercial Pilot Licence (CPL)

A **Commercial Pilot Licence (CPL)** is a type of pilot licence that permits the holder to act as a pilot of an aircraft.

Different licenses are issued for the major aircraft categories: airplanes, airships, balloon, gliders, gyroplanes and helicopters.

A CPL will typically have no expiry date. However, a valid medical certificate and valid rating will be required to use it.

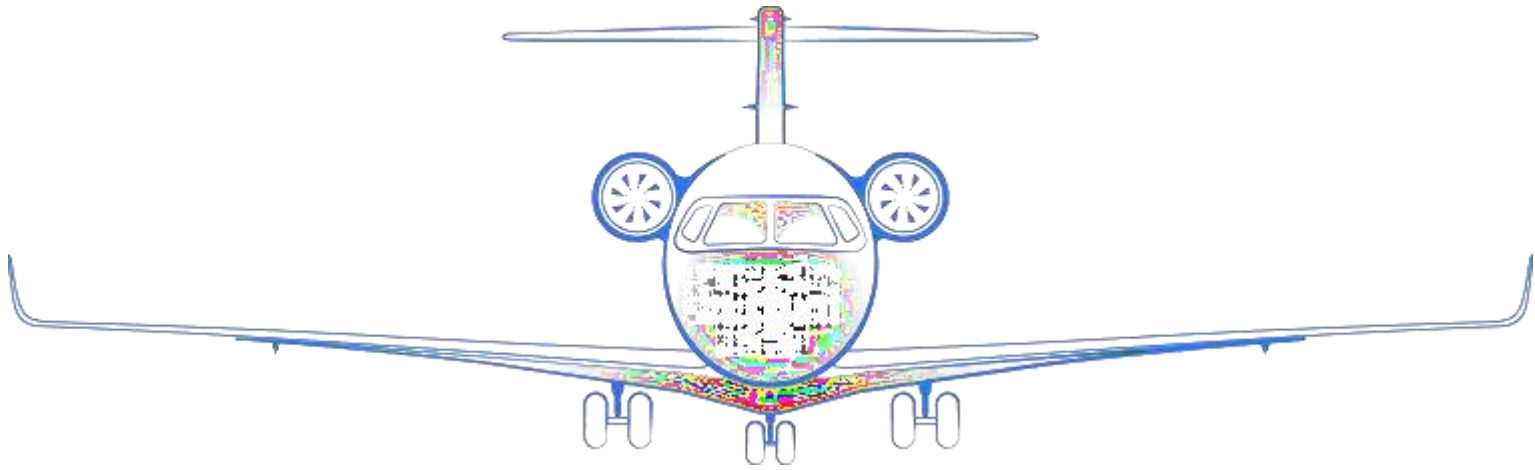
